Re: Records Request

Dear Mr. Quemere:

The Massachusetts Department of State Police ("Department") has received and reviewed your request for "a list of Massachusetts state troopers and the number of complaints that have been filed against them." In a June 4, 2014 email to the Department, you further clarified your request to include only "information about all currently employed state troopers." The Department considers your request as a submission pursuant to G.L. c. 66, §10, the Massachusetts Public Records Law. Enclosed you will find records responsive to your request.

Please note that based on information this office has received from the Department's Division of Standards and Training, the records being provided were produced by the operational software currently used by the Department's Division of Standards and Training. **The computation of statistical data pertaining to your records request accurately reflects all data collected since the implementation of the current software application, which was on or about October 1, 2010.**

The legacy data, or data that existed prior to the implementation of the Department's current software, is indeterminate for statistical purposes. Meaning, while the legacy data has been entered into the Department's current operational software, this data is not cataloged in a manner that factors into the statistical algorithm used to produce the attached records. As such, it cannot be easily differentiated for the purpose of aggregating complaint data. Collection of data prior to the implementation of the currently used software would require an extensive and time-consuming attempt to locate and hand-search any archived records that might be available. Therefore, as it will require additional Department resources to produce such records, if you wish to receive a cost estimate for the costs associated with this additional collection of legacy data,
