Mr. Quemere,

The Dartmouth Police Department received your request pursuant to the Massachusetts Public Records Law for the following records .... "On or about October 10, 2020, Brock Cordeiro reported to the police department that Rayla Campbell had threatened him; please provide all reports and other records related to this incident".....

Please see attached.

The record(s) requested contained personal information such as date of birth(s), social security number(s), phone number(s), and victim(s) information which was redacted; all redacted information is personal and intimate in nature. As a result, such information must be redacted under law following the guidelines of Public Record Law M.G.L. c. 66, § 10 and Using:

Exemption (c): This exemption applies to "personnel and medical files or information; also, any other materials or data relating to a specifically named individual, the disclosure of which may constitute an unwarranted invasion of personal privacy." The records requested contain information which, if disclosed, would constitute an unwarranted invasion of personal privacy. Such information contains intimate details and the privacy interests involved outweigh the public interests in the disclosure of that information.

Please be advised that pursuant to 950 CMR 32.00 and G.L. c. 66, § 10A(a) you have the right to appeal this decision to the Supervisor of Public Records within 90 calendar days. Such appeal shall be in writing, and shall include a copy of the letter by which the request was made and, if available, a copy of the letter by which the custodian responded. The Supervisor shall accept an appeal only from a person who had made his or her record request in writing. Pursuant to G.L. c. 66, section 10A(c), you also have the right to seek judicial review my commencing a civil action in the superior court.

The estimate of fees and cost associated with this request has been waived.

On Saturday, 10/10/2022 at approximately 2119 hrs. I was dispatched to \*\*\*\*\* in order to speak with a **Brock Cordeiro** pertaining to threats being received online. Upon arrival, I spoke with Cordeiro who explained that on a Facebook discussion between the hours of 1833 and 1841 hrs. a **Rayla Campbell** (aka. Rayla Niland) was angry with him as a result of being blocked from the discussion of which Cordeiro is an administrator. Cordeiro explained that Campbell issued a vague threat during that time which is the reason he blocked her. It would be later in the evening that Cordeiro would receive a call from **Thomas Mountain**, warning him about Rayla's anger and likelihood of retribution towards him. Cordeiro states that Mountain is a mutual acquaintance of both he and Rayla.

Cordeiro explained that while speaking with Mountain, he would play a voicemail in which Cordeiro was being threatened by Rayla. During this voicemail, Rayla can be heard stating that "I will find out where this little motherfucker lives and beat him a new asshole." Cordeiro went on to say that Mountain would also provide him with a digital copy of the above mentioned voicemail. Cordeiro went on to say that since that occurrence, Rayla has initiated a "smear campaign" against him on social media. Cordeiro states that it is known that Rayla employs a squad of armed security guards and is recently visiting the Dartmouth area for a political event to take place at the Dartmouth Mall. Cordeiro states that Rayla is also known for her explosive temper and has had it exemplified to him on several previous occasions.

Cordeiro states that he fears that given Rayla's prior history, coupled with her "militia" and today's actions, she could present a credible threat of violence to himself and/or \*\*\*\*\* that resides with him. Cordeiro explains that Rayla is a failed political candidate for the Republican nomination for candidate of the 7th Congressional District. Cordeiro also made mention that Rayla maintains a "write-in" candidacy for 2020. Cordeiro states that Rayla is the captain of "Black Voices for Trump" which is the state Coalition of the official Massachusetts for Trump campaign. Cordeiro further explained that Mountain is a vice-chairman of the Massachusetts Republican Party and Cordeiro himself is a vice-chair of the Massachusetts for Trump 2020 and the Massachusetts State GOP Committee man for the Second Bristol and Plymouth State Senate District. Cordeiro is requesting a formal documentation of this incident. Report filed.

It should be noted that this report has been amended at the request of Cordeiro due to an error in suspect identification.

STATEMENT: I had a discussion on Facebook Messenger tonight between 6:33-6:41pm with Rayla Campbell aka Rayla Johnny Miland of 19 Jane Street in Randolph, MA as she was very angry, as I blocked her from the Facebook Group of which I am the Administrator. She issued a vague threat to me at the time. Later tonight I received a phone call from Thomas Mountain of Newton, MA, warning me of Rayla's anger and the possibility of retribution. Mr. Mountain's phone number is ... Mr. Mountain is a mutual acquaintance of both me and Rayla. Mountain played for me a voicemail where I was threatened by Ms. Campbell. In the voicemail Rayla stated, "...I will find out where this little mother tucker lives and beat him a new asshole." Tom Mountain provided me a digital copy of the entire voicemail. Since then Rayla has commenced a smear campaign against me on social media. It is well known that Rayla Campbell employs a squad of armed security guards, recently visiting Dartmouth with several of them at a political event at the Dartmouth Mall. Rayla is also well known for her explosive temper having exemplified it to me and others on several occasions. I fear that her history, coupled with her "milita" and her actions today constitute a credible threat of violence to me, who resides with me and my home. Rayla Campbell is a failed political candidate for the Republican nomination for candidate of the 7th Congressional
